PRICING POLICY:

- 1. Rates in the table on page 1 of this document are subject to change at any time by the Owner.
- 2. Camplife.com is our online reservation system; small transaction fees apply to reservations, including a standard reservation fee of \$3.50 and a cancellation fee of \$5.00, if the reservation cancellation is made within 10 days of arrival.
- 3. Reservation Cancellation Policy is as follows:
 - a. Transient Guests must cancel 10-days prior to their actual arrival date to receive a full refund, minus the credit card fee, reservation fee, and the cancellation fee.
 - b. Transient Guests that cancel within 10-days of their reservation will be charged 50% of the paid reservation; a refund of the remaining 50% shall be refunded to the guest, minus any fees that apply.
 - c. Transient Guests that book the minimum 2-day reservation, multi-day reservations, or weekly discounted rate reservations, or more, and then terminate their reservation earlier than the documented reservation departure date, shall be charged the daily standard or premium rate, fees, and be charged 50% of the paid reservation for early cancellation, and fees that apply to lost revenue, minus any other fees or sales that apply that are unpaid.
 - d. Transient Guests that terminate their reservation early shall pay a standard or premium regular guest rate + additional charges that apply to lost revenue as determined by the Owner. The Kalbus General Manager may provide extenuating circumstances to the Owner, and if authorized, can make an adjustment to the lost revenue charges – a minimum fee of \$200.00 for lost revenue shall apply to early departures.
 - e. EAA AirVenture (Special Event Rate) Guests pay a reservation rate of \$600.00 whether they stay 1-day or the entire week. If the EAA Guest departs early, Kalbus Country Harbor reserves the right to allow new reservations to be made available on that site.
 - f. EAA AirVenture (Special Event Rate) Guests must cancel 30-days prior to the event date to receive a full refund, minus any fees that apply.
 - g. EAA AirVenture (Special Event Rate) Guests that cancel 20-days prior to the event date receive a 50% refund, minus any fees that apply.
 - h. EAA AirVenture (Special Event Rate) Guests that cancel 10-days prior to the event date DO NOT receive ANY refund.
- 4. Seasonal Rates apply to seasonal guests making reservations from 1 May through 31 October.
- 5. A storage rate of \$200.00 or \$300.00 applies to seasonal guests requesting to store their camper onsite during the winter closed season that runs from 1 November to 30 April.
- 6. Seasonal guests that terminate their reservation early shall pay a standard or premium regular guest rate + additional charges that apply to lost revenue as determined by the Owner. The Kalbus General Manager may provide extenuating circumstances to the Owner, and if authorized, can make an adjustment to the lost revenue charge.
- 7. Seasonal guests that terminate their reservation early, and fail to pay the adjusted rate, shall be banned from the property and charged with trespassing should they be found on the property for any reason, including boat launch.
- 8. ALL Guests, including Seasonal and Transient Guests, shall abide by the rules and policies of the campground. All people and pets residing on the campground are considered our GUESTS and GUESTS can be asked to leave the campground for failure to follow our policies and rules.
